

One 4-hour course will be offered from 8 a.m. - noon | One 4-hour course from 1 p.m. - 5 p.m.

MORNING - COURSE 8am-12 noon

Advanced Schools and Large Buildings – Radon Measurement NRPP ID # KSU-222 (4 Cat I hrs)

This four-hour version of KSU-222 course focuses on the skills you need to understand the major factors unique to radon measurement in schools and large buildings. The goal of the course is to help you design and manage radon measurement projects in schools and large buildings. Topics include test preparation, determining test locations, test procedures, required measurement conditions, quality control and test documentation. The course is built around the American National Standards Institute (ANSI) and AARST, Protocols for Conducting Radon and Radon Decay Product Measurements in Schools and Large Buildings.

AFTERNOON - COURSE 1-5pm

Radon Services and Contractor Opportunities NRPP ID # KSU-229 (4 Cat I Hrs)

This four-hour pre-conference workshop will engage current radon professionals and interested contractors in evaluating business and individual leadership opportunities regarding radon services. Important mitigation concepts and techniques for new construction, existing homes and system performance diagnostics as well as training needs and radon standards and policy initiatives will be reviewed. Emphasis will be placed on benefits for individuals and businesses involved or looking to be involved in providing radon related services.
