Courses and Descriptions

Two 4-hour courses will be offered from 8 a.m. - noon | Two 4-hour courses from 1 p.m. - 5 p.m.

MORNING - COURSE #1 8am-12 noon

Business Tune Up: Staff Training, Media, and Promotions

NRPP ID # KSU-234 (4 Cat I hrs)

This will be a 4-hour, highly interactive course designed to help radon professionals think critically about and review basic marketing principals, introductory training in radon for professional staff, community outreach, and promotion of the company through online advertising and social media. The 4-hour course will require attendee participation through worksheets and discussion covering market segmentation in radon, building a company FAQ on radon for customer communication, basics of social media outreach, design of simple online advertisements, and setting online advertising budget and display parameters.

MORNING - COURSE #2 8am to 12 noon

Personal Protective Equipment for the Radon Professional (and Other Practicalities)

NRPP ID SPRUCE 242 (4 Cat I Hrs)

With new OSHA requirements for safety applicable to the Radon professional, it is important to keep up with these requirements to ensure your company is in proper compliance. A focused review of personal protective equipment (PPE) and its use, with logistics for the radon professional, including mitigators and testers. The use of respirators is reviewed, along with specific guidance. The course also covers hazards recognition for the radon professional, including hazards the professional may not be aware are present at some job sites.

AFTERNOON - COURSE #3 1-5pm

Advanced Schools and Large Buildings – Radon Measurement

NRPP ID # KSU-222 (4 Cat I Hrs)

This four-hour course focuses on the skills you need to understand the major factors unique to radon measurement in schools and large buildings. The goal of the course is to help you design and manage radon measurement projects in schools and large buildings. Topics include test preparation, determining test locations, test procedures, required measurement conditions, quality control and test documentation. The course is built around the American National Standards Institute (ANSI) and AARST, Protocols for Conducting Radon and Radon Decay Product Measurements in Schools and Large Buildings.

AFTERNOON - COURSE #4 1-5pm

Radon Resistant New Construction

NRPP ID# KSU-209 (4 Cat I Hrs)

This course focuses on understanding the basics of radon gas, the national guidelines for designing and installing radon mitigation systems in new residential buildings, the status of IRC code updates and proposals, and other codes pertaining to radon-resistant new construction.
