**Descriptions:**

**Morning Course #1: Radon Resistant New Construction (\$80)**

**Course Details: 8 a.m. to noon Friday**

This course is critical with the new green homes of today's builders. With this four (4) hour course, you will learn the basics of radon, radon decay and why it is a problem in homes. We will cover health risks for radon and most importantly the approved techniques for radon resistant new construction, which include both passive and active systems. This course does NOT prepare you for the NRPP Advanced RRNC 2.0 Certificate Program UNLESS the instructor utilizes the RRNC 2.0 Advanced Certificate Program Workbook.

4 hours of CE – John Seidel, Instructor

**Morning Course #2: Inspecting the Radon Mitigation System with Home Inspection (\$80)**

**Course Details: 8 a.m. to noon Friday**

This course provides information about properly installed radon mitigation systems, along with an overview of radon, radon entry and behavior, standard radon mitigation methods, available system checklists from national programs and regulatory states, and lots of examples of what and what not to do.

**Afternoon Course: Radon Certification Criteria - What do you need to know to do your job? (\$80)**

**Course Details: 1 - 5 p.m. Friday**

This four-hour course taps the experience of radon measurement and mitigation professionals to generate a list of essential requirements that employees and new practitioners need to achieve certification, hold certification and perform quality radon measurement and mitigation work. Through the process of group question and answer sessions and discussions, attendees will better understand their own and their employees value, potential and performance level. Participants will contribute individually leading small group sessions as well as contributing during instructor led group discussions
